

# QuantoPay Cookie Policy

QuantoPay Ltd. a company incorporated in the United Kingdom, having its principal place of business at the Leadenhall Building, 122 Leadenhall Street, City of London, EC3V 4AB, United Kingdom (hereinafter referred to as (“**QuantoPay**” “**we**”, “**us**” or “**our**”) uses cookies and similar technologies to recognize you when you visit our QuantoPay application (“App”) or our QuantoPay website at [www.quantopay.com](http://www.quantopay.com) (“Website”). This Policy further explains what these technologies are, why we use them, as well as your rights to control our use of them.

## **What are cookies?**

Cookies are small data files that are placed on your computer or mobile device when you visit a website. Cookies are widely used by website owners in order to make their website work more efficiently, as well as to provide reporting information.

Cookies set by the website owner (in this case QuantoPay) are called “first-party cookies”. Cookies set by parties other than QuantoPay are called “third-party cookies”. Third-party cookies enable third-party features and functionalities to be utilized within the scope of use of the QuantoPay App and Website (e.g. Advertising, interactive content, and analytics). The parties that set these third-party cookies can recognize your computer when you visit the Website.

## **Why does QuantoPay use cookies?**

QuantoPay will use first party and third-party cookies for several reasons throughout your QuantoPay experience. Some cookies are required for technical reasons, in order to serve the functionality of the App and the Website (respectively) – these cookies are classified as “essential cookies”. Other cookies also enable us to track and target the interests of our users to enhance their experience on our platforms. Third parties serve cookies through our Website for certain purposes as described below.

## **How can you control your cookies?**

You have the right to decide whether to accept or reject the use of cookies. You can exercise your rights by setting your preferences accordingly, and either providing or revoking consent of use. You cannot revoke essential cookies as they are strictly necessary for QuantoPay to provide our services.

## **Analytics and customization cookies**

QuantoPay utilizes certain cookies to collect information that is used either in aggregate form to help us understand how our Website is being used or how effective our marketing campaign are, or to help customize your QuantoPay experience.

## **How can I control cookies on my browser?**

As a means through which you can revoke the use of certain cookies, you can adjust your web browser controls. This process is distinguished across various web browsers.

## **Does QuantoPay serve targeted Advertising?**

Third parties may serve cookies on your personal device to serve advertising through our platforms. These companies may use information about your visits to the Website or other websites in order to provide relevant advertisements. They may further employ technology that is used to measure the effectiveness of advertisements.

## **How often will QuantoPay update this Policy?**

QuantoPay may update this Policy from time-time in order to reflect changes to the cookies we use or for other operational, legal or regulatory reasons. Please therefor revisit this Policy on a regular basis to stay informed about the use of our cookies and related technologies.
